## WINDERMERE ROAD, LEIGH – PROHIBITION OF WAITING AND PROHIBITION OF STOPPING AT SCHOOL ENTRANCES

## **NOTICE OF PROPOSALS**

**NOTICE IS HEREBY GIVEN** that Wigan Borough Council, in exercise of the powers under Section 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act 1984, proposes to make the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 156) Order 2025.

The effect of the Order will be to revoke no waiting at any time on:

- Windermere Road, Leigh (north side) from its junction with Glebe Street to its junction with Leigh Road
- Windermere Road, Leigh (south side) from its junction with Leigh Road for a distance of 46 metres in a westerly direction
- Windermere Road, Leigh (south side) from a point 10 metres east of its junction with Grasmere Street to a point 5 metres west of its junction with Grasmere Street
- Windermere Road, Leigh (north side) from a point 5 metres west of its junction with Grasmere Street to its junction with Glebe Street

The effect of the Order will be to introduce no waiting at any time on:

- Windermere Road, Leigh (north side) from its junction with Grasmere Street to its junction Leigh Road
- Windermere Road, Leigh (south side) from a point 5 metres west of its junction with Grasmere Street to a point 13 metres east of its junction with Grasmere Street
- Windermere Road, Leigh (south side) from a point 10 metres east of its junction with Gordon Street to a point 6 metres west of its junction with Gordon Street
- Windermere Road, Leigh (south side) from its junction with Leigh Road for a distance of 46 metres in a westerly direction

There will be limited exceptions permitting vehicles to wait to enable people to board or alight; for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers; for local authority, Water Companies and Post Office purposes; if the vehicles are fire service or police vehicles or ambulances, (liveried vehicles) or in connection with a funeral; to take on fuel, water or air at any garage; for the delivery or collection of goods and for loading or unloading; or the avoidance of an accident.

The effect of the Order will be to revoke no waiting at school entrances:

 Windermere Road, Leigh (south side) from a point 21 metres west of its junction with Glebe Street to a point 16 metres east of its junction with Glebe Street

The effect of the Order will be to introduce no waiting at school entrances on:

 Windermere Road, Leigh (south side) from a point 12 metres east of its junction with Glebe Street for a distance of 37.5 metres in a westerly direction

There will be limited exceptions permitting vehicles to wait; to enable the removing of obstructions to traffic, if the vehicles are fire service or police vehicles or ambulances, (liveried vehicles), road works and works by statutory undertakers; or for laying, erection, alteration or repair in or adjacent to

the said school entrance markings of any sewer, main, pipe or apparatus for the supply of gas, water electricity or any telecommunication apparatus as defined in the Telecommunications Act 1984.

The Order also provides that if any vehicle is left in any road or length of road affected by the Order in contravention of any provision of the Order a penalty charge (in the amount set by the Council) shall be payable and/or the vehicle may be removed.
